JOB OVERVIEW

The role of the HNW Kids Childcare staff member is to supervise children participating in childcare activities of HNW and teach prepared curriculum during weekend and weekday ministry programs. Children can range in ages 8 weeks through 6th grade depending on the specific event.

ESSENTIAL DUTIES AND RESPONSIBILITIES

- Manage a classroom by providing a safe and secure learning environment for children.
- Teach prepared lesson plans with materials and curriculum provided.

OTHER SKILLS AND ABILITIES

- The successful candidate must be a Fully Devoted Christ-follower, called and dedicated to the ministry of children and parents and fully support the ministry of Houston Northwest Church and its leadership team. This individual's commitment to Christ will be evidenced in their personal life, family relationships, and ministry. Incumbents daily walk with God will be an example to the children, parents and others with which (s)he interacts.
- The ideal candidate will have the ability to work independently as well as in team environments.

PHYSICAL DEMANDS

The physical demands described herein are representative of those that must be met by an employee to successfully perform the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.
